1. Confirmation of Minutes of 8th of June 2025

2. Reports

President's Report:

Training days – trialing of new format:

- a. Consider asking riders if they want a specific timing between their rides for training days i.e. back-to-back.
- b. Alternately could create 30 slots and riders pick their own slots, and rider could choose their own time and ie then if follow up test.
- c. If rider picked their own slot you would potentially need to group all the tests at a certain level i.e. all prep or all mediums together to prevent chopping and changing for riders.
- d. Would potentially need to cluster lower level tests and higher levels tests with arena familiarization in between to allow for judges not to chop and change.
- e. Potentially need a "feedback session" as a 3rd option in drop down list.
- f. Barb and Jan report that if we created template for training days this way it could be copied for future ones if this was created.
- g. If we created training days with above we would need to alert riders that we have only added so many tests at each level and that if they are filled and riders cannot access a ride at the level they wanted.
- h. This would allow riders that wants two tests consecutively could do that, or separately as they prefer and would encourage riders to enter sooner to obtain their preferred times and allow the club to better gauge numbers earlier, it would mean there is less work to be done creating a draw.
- i. Riders could also potentially select their own jobs from a drop down list, with each job deleted from the list once selected, ensuring that once a particular job is taken it is no longer available. Potentially for jobs like penciling there would be a selection of different time slots for this job to choose from.
- j. Proposal that the number of jobs has to equal the number of horse rider combinations but potentially this could

be based on the number of horses or the number of riders.

- k. Can allocate either to the number of riders or horses.
 - a. Tameka to ask if Peter is able to do this for the October Training day. If this is not possible via the website we need enough notice to try and organize this via nominate.
- I. If we are able to proceed plan to post an announcement onto face about trialing a new training day booking format
- m. Agreement that monies paid to be forfeited if scratched after closing date without medical or veterinary certificate for training day.

- b. Maggie has flyer completed.
- c. Barbara to print tests for August no Frills.
- d. Tests involved 2,3 including prep 2,3 to Advanced.
- e. Once Pamphlet created -> Pete onto the AEC/SDDC website, Tisa to drop off at horseworld, vets, Denmark Coop, for patients to take A5 if possible. Tameka to be sent to put on FB, Viriginia to drop off at Denmark Coop.
- f. Setup to be done the day before.
- g. Arena needs to be booked from 4pm the evening before if setting up the date before.

- k. Need marshals but not a steward as unofficial.

- m. Virginia- 3 Judges lined up.
- n. Virginia to be sent the entries to allocate the judges and ensure no clashes.
- o. Maggie to be sent the Entries to create the draw.

6. ATO Authorized Contact -Jan Madigan;

 Jan and Tameka to be the authorized contacts and that going forward that this is part of being the role of Treasurer and Secretary.

7. Members to create a list of what is required for each committee role - a role description/handover document.

8. Tameka Proposes a Dropbox or Google file:

Club members to be able to access with password or link that has a time limited expiry.

Barbara and Maggie support the idea of a club Dropbox.

Question as to whether an email address is required for this.

Tameka: on looking into this it appears that this is required to set up either account. Both offer free basic accounts.

9. EA Grants - Virginia Longley

- a. Because the SDDC now utilize nominate we are eligible for grants from Dressage WA whenever running official competitions i.e. Southern Solstice, April Official Competition and the Albany Show.
- b. The Grants depend on the number of tests over all and the number of tests at each level.
 - a. A minimum of 30 test entries is required for a grant of \$150
 - b. If at least 3 Small Tour Tests are held then we are eligible for atleast \$150 in grant money. This is the same for Medium and Para tests.
- c. Clubs also receive grants for securing interstate judges and whether they conduct workshops of at least \$750.
- d. At the 2025 Southern Solstice there were 91 Official tests, 4 para tests, FEI to be confirmed.
- e. Criteria:
- f. Nominate needs to be used

g. Jan to send application letter too dwaclubs@gmail.com with a summary of the event and banking information.

Virginia to send information sheet to committee members to review.

Barbara to finalize results on Nominate for April and Southern Solstice 2025 competitions if we are able to retrospectively claim grants for these events.

The Albany Ag Show could potentially be eligible if we achieve more than 30 test entries.

10. Proposed utilization of Coaches at Training Days

- a. Virginia discussed with Andrew Forbes who proposed 20 minutes to be the optimum time if a rider is to be coached in between test rides.
- b. Andrew offered to do this for the club at no expense.
- c. Louise Hillman was also contacted, she is interested however proposed a fee of \$40.00 for 20 minutes of coaching.
- d. Amanda Pritchard responded advising she was interested in assisting but was not sure what her fees would be at this point in time.
- e. There is a concern from committee members that this might be too many new proposals regarding training days being trialed at once.

If this was trialled at a future training day an option might be to list "Coaching session" as one of the drop down options and that the rider is to pay for this at the time of entry.

Alternately the rider could be directly responsible for payment of the coach to ensure the club does not end up with additional expenses.

To be discussed further at a later date.

11. Visiting coaches

a. Tisa – proposed we arrange visiting coach clinics pending interest from riders.

Maggie Suggests this may be something to bring in for next year.

12. Southern Solstice 2026 17th and 18th of Jan;

Committee to email Tameka by the end of week with one of the roles from the Committee rolls.

Fiona- Sponsor to host visiting judges at Big Grove Bed and Breakfast.

Smallest sponsor amount to be \$250.00 proposed by Maggie

Part of the sponsorship has to be in cash/money with minimum being \$150 cash with the rest as vouchers/prizes if required.

Ask for \$250 from people believed to be a general sponsor or anything above \$300 for Major sponsors. Major sponsors get a logo on a rug.

Para Tests at the Southern Solstice 2026:

This needs to be made clear in the schedule.

Sandra was not at the committee meeting but previously suggested not having rosettes as there was previously a large expense for these.

Tisa to review and see if there are any rosettes in the Sea Container

Barbara feels that the championships should require a minimum percentage and that the number of riders required for a championship at the higher levels of competition i.e. medium and above be reduced to 3. If we get enough sponsorship and grant money to cover costs then reducing the number of riders required for Championship to 3 could be reconsidered.
